<ul> <li>Courses in which academic dishonesty was involved are not eligible for GPA recalculation.</li> <li>A student's GPA can only be recalculated if the original and the repeated course are taken at UMKC or another UM System school.</li> <li>The original course and the repeated course must be a direct equivalent.</li> <li>Students may repeat a single course for GPA calculation twice (for a total of three completions). Please note that financial aid may not be available on a third completion if a passing grade was earned.</li> <li>Original and repeated courses must be taken Fall 2007 or later.</li> <li>Repeated courses may not be taken on a CR/NC basis.</li> <li>Original grades cannot be replaced with a 'W', 'WF', 'I', or 'T.'</li> <li>No more than 15 semester hours can be dropped from the calculation of a student's GPA by repeating course work.</li> <li>Requests approved for GPA recalculation will prefix the original grade with an "R." Transcripts will note that such grades are excluded from GPA calculations.</li> <li>Courses cannot be repeated for credit towards the degree unless specifically noted.</li> <li>The course repeat option is not available when requested for a term that was a part of a previous degree award.</li> <li>Once the GPA recalculation has been recorded, the action cannot be rescinded.</li> <li>Please refer to the appropriate School or College section of the undergraduate catalog for information on specific rules for course repeats.
