

Pathway help: Cross Campus Enrollment FAQ for UMKC Student

FAQ: UMKC student looking to take a course at MU, UMSL or S&T

1. What is Cross Campus Enrollment?

Cross Campus enrollment gives currently-enrolled, undergraduate degree-seeking students at any of the University of Missouri (UM) Schools, the opportunity to take a class at another UM campus.

Graduate Students should visit the UMKC Catalog for information on the UM Visiting Graduate Student
Program.

2. Who are the other UM Schools?

University of Missouri, University of Missouri – Kansas City, University of Missouri – St. Louis, and Missouri S&T are the institutions that make up the UM System.

3. Who is the host institution?

The Host institution is the school to which you would like to take a cross enrollment class.

4. Who is the home institution?

The Home institution is the school to which you are enrolled as a degree-seeking student.

5. Do actions I take at my Home campus carryover to my Host campus, i.e. FERPA, AAA, name change, etc.?

No, you must adhere to all policies, procedures and deadlines and take action at each institution in which you are enrolled.

6. Why should I cross enroll?

Cross Campus Enrollment gives student more flexibility with their course selection, no application fees, automated transfer of credits after completion of the work at the Host campus and may enable you to stay on target to graduate on time. If a course is full on your home campus, you might be able to enroll in the same course on another campus.

7. Is there an application fee?

No, there is no application fee. By submitting your request through the Cross campus enrollment page in Pathway, your data will be automatically shared with the other campus so they can review your eligibility to enroll.

8. How do I know this course will transfer to UMKC and meet degree requirements?

Please check with your home campus advisor prior to enrollment to ensure that the course will transfer. You may also check the Transfer Equivalency database at https://transferology.com/school/umkc

9. How do I prove I have met a pre-requisite?

Depending on the UM campus you are enrolling in a course, you will need to provide your unofficial transcript or Student Academic Advising profile for permission to enroll into the course. See below for each UM campus contact.

University of Missouri (MU) – Contact the department offering the course.

- University of Missouri- St. Louis (UMSL) Contact the department offering the course.
- Missouri University of Science and Technology (S&T) Contact the instructor of the course.

10. What if I have already applied or am already attending the Host campus and I want to participate in Cross Enrollment?

By submitting your request through the Cross Campus Enrollment page in your Pathway, your data will be automatically shared with the Host campus so they can review your eligibility to enroll.

11. Can I receive Financial Aid to help me pay for a course at another institution?

Possibly. A consortium agreement is a written agreement between two schools where one of the schools provides some of the instruction for students enrolled at, and receiving the degree from the other school, and the school awarding the degree or credential agrees to give credit to the student for that instruction/coursework. The consortium also establishes the terms under which financial aid is awarded for the courses in question. If you are receiving aid and want to have that aid help cover the costs at the other school, contact the Financial Aid and Scholarships Office at 816-235-1154.

12. Will I get one bill or two?

You will receive a bill from each of the campuses in which you are enrolled. The billing statement will be sent to your UM assigned email account.

Please visit the campus Cashier's Office website at each of the campuses you are enrolled to learn more about their tier tuition, due dates, refund schedules, and/or any additional student account questions you may have.

13. Can I use my UM Educational Assistance?

Yes. You will need to complete the necessary UM form and indicate which campus the course is being offered. Once the form has been completed and the necessary signatures obtained, UM HR will route the form to the appropriate campus for processing.

14. I have a hold on my account that blocks enrollment at UMKC. Will this affect my ability to participate in cross campus enrollment?

If you have a hold on your account that blocks enrollment at UMKC you will need to have the hold resolved before you are able to participate in cross campus enrollment at MU, UMSL and S&T. 15. Will I need to send a transcript back to UMKC after completing my course?

No. As a benefit of participating in cross campus enrollment, UM campuses will share transcripts once grades have been posted.
