#### HLC: What's it all about?

- 10-year accreditation cycle
- Verifying that institutions meet standards established & evaluated by peers
- Promoting institutional self-knowledge and advancement
- Documenting continuous Institutional improvement
- Providing assurance to the public about quality
- Building and maintaining confidence in higher education



# Speaking HLC's language

#### Comprehensive evaluation

- Confirms that the institution continues to meet the Criteria for Accreditation, is pursuing institutional improvement and complies with requirements set by the U.S. DOE.
- Evaluations are conducted by teams of peer reviewers.

#### Assurance argument

- Narrative that builds the case for how the institution meets criteria for accreditation – *limit 35,000 words*
- Evidence
  - Organizational artifacts that support claims
  - Role of HLC Board in final decision regarding Institutional status



## Criteria

- 1. Mission
- 2. Integrity: Ethical & Responsible Conduct
- Teaching & Learning: Quality, Resources& Support
- 4. Teaching & Learning: Evaluation & Improvement
- 5. Resources, Planning & Institutional Effectiveness
