

CHANGING STATUS TO F-1 OUTSIDE THE US – OR – RETURNING TO US ON NEW I-20 RECORD

- Fill out this form and have it signed by your ACADEMIC ADVISOR, keep a copy for your records
- Attach updated financial documents:** You must show proof of funds: bank statements dated within the past 6 months, an updated Financial Guarantee from your sponsor, GTA/GRA offer letter, letter of monthly stipend.
 - Sponsored Students:** Your Financial Guarantee must have new, corrected dates
 - If the financial documents are not in your name, you must submit a valid Affidavit of Support found here: <https://www.umkc.edu/isao/docs/affidavit-of-support.pdf>
 - If you do not show correct proof of funds, we will not be able to issue you a new I-20.
- Submit items 1 and 2 to ISAO. **If request is incomplete, we will not be able to process your request.**

REMINDERS

- You now have a new/different SEVIS ID. **You must pay the I-901 SEVIS fee again on this new SEVIS ID:** www.fmjfee.com
- If your current F-1 visa will still be valid at the time you plan to return to the US, you do NOT need to apply for a new F-1 visa.
 - However, if it has already expired or if it will expire within 3-6 months of the date you plan to return, then you should apply for and receive a **NEW F-1 visa** before attempting to return to the US.
- You will not be able to return to the US with your new I-20 more than 30 days before the Program Start Date listed on the new I-20.
