Course Equivalency Review

Transfer course equivalencies are handled through a workflow process within Perceptive Content. The process begins with the following steps:

- A request for a course review will start with an advisor raising a flag in Connect which will generate an email to the Transfer Credit Coordinators in the Registrar's Office.
- The Transfer Credit Coordinators will use the information from the Connect flag to create an eForm to be reviewed by the Academic Unit.

Below are the procedures for Academic Unit Reviewers to complete the course equivalency review process.

Note: In order to access Perceptive Experience, you must be connected to the UMKC's secured

Procedure: Approve the Course Equivalency eForm

If there is a transfer course equivalency that needs your review, you will receive an email from <u>transfercredit@umkc.edu</u> to alert you to your assigned queue(s) to review the course equivalency eForm.

1) Log in using your university credentials, and click the **Connect** button.



2) On the Home page, click the Workflow tile.

7) Once the appropriate match is listed, expand the **Status** menu in the Approval Details section and select **Approve** or **Modify**. The Approver and Approval Date fields are automatically populated.

- a) Choose **Approve** if the appropriate equivalency was on the eForm to begin with.
- b) Choose **Modify** if you added the equivalency or result that was chosen.
 - i) When choosing **Modify** you must include notes in the *Modifier Notes to Registrar Office* field before completing.
- 8) Click the Route Forward button in the menu bar above the form.



a) Click **Yes** in the Save Changes dialog box that appears. The form is then routed forward to the Transfer Articulation Officer (TAO).



9) If there is another course in your queue for review, it will pop up automatically until the queue is empty.

Notes:

- If a course does not have a direct equivalency in your area but should be reviewed by another department for potential direct equivalency, please make note of that and route forward. That information will be used to re-route the eForm to another academic department for review.
- The eForms will be auto-routed forward to the TAO after 14 (calendar) days in the queue.
- Depending on the outcome of the review, the TAO may re-route the eForm back to the academic unit queue for additional review.
 - *eForms that are routed back to the unit review queue will be auto-routed forward after 14 (calendar) days.*

Next steps for the completed equivalency review:

- 1) The Transfer Articulation Officer will review the approved course equivalency and confirm there are no conflicts with MOTR (CORE 42) course equivalencies and will route forward to the Registrar's Office.
- 2) The Registrar's Office will create or update any transfer rules in Pathway according to the result of the equivalency review and update student records as necessary.
- 3) The Registrar's Office will respond to the Advisor/Inquirer who started the review process with the results of the review. That person is then responsible for closing the loop with the student to ensure they know the outcome of the review.
