## MISSOURI RETURNING HERO ACT PROVISIONS:

Students who are eligible to receive 100% of tuition and fees paid through Post 9/11 Chapter 33 or VR/E Chapter 31 benefits are not eligible to receive the MRHA credit and VA education benefits for the same enrollment period.

Undergraduate student tuition charges are limited to \$50.00 per credit hour and all other fees associated with enrollment are not discounted because of MRHA.

Graduate student tuition is limited to 30% of total tuition and fee charges.

Students must maintain a cumulative 2.5 GPA to utilize MRHA.

Students must be enrolled in a program leading to a certificate, associates, bachelor's, or master's degree. Professional programs (Law, Medical, Dental, Pharmacy) are excluded from receiving MRHA credit.

MRHA credit will not be applied to student accounts after the first day of the term.

Students receiving tuition assistance must provide a copy of their Tuition Assistance Authorization form as well as a UMKC VA Enrollment Certification Request form to the School Certifying Official.

Students must be registered to vote in Missouri, or are eligible to vote, as determined by the Missouri Secretary of State, or is a current Missouri resident.

Any balance due on student accounts is subject to a 1% charge if left unpaid from one billing cycle/invoice to the next. A late fee of \$25 will apply whenever one billing cycle/invoice due date passes and no payment is made. I understand that I will be unable to enroll for future terms and will not be able to receive transcripts or diplomas if I have an unpaid balance on my account.
